

ICEmarket Privacy Policy

We at ICEmarket understand that doing B2B negotiations online involves a great deal of trust on your part. We take this trust very seriously and make it a high priority to ensure the security and confidentiality of the information you provide to us.

Within the EU/EEA, the General Data Protection Regulation (GDPR) applies from May 2018. In accordance with applicable data protection legislation, Jadranski skiperi d.o.o./ICEmarket ("Website"), or the company otherwise specified as data controller, is responsible for the processing of your personal data as set out below. What information we collect

We receive and store any information you enter on our website or give us in any other way. This includes information that can identify you ("personal information") directly or through use of cookies that are requested for certain services (see: [Cookie Policy](#)).

ICEmarket application (<https://app.icemarket.hr>) is using contact information for populating Customers and Suppliers database through registration process for the affiliated marketing event International Charter Expo ("ICE") via myICE portal (<https://registration.internationalcharterexpo.com>) with prior consent from the users.

We record all activities on the Website such as inquiries from customers and pricing of suppliers. While the customer activities are being used for general statistical and market analysis, all supplier activities are covered by a non-disclosure agreement which is part of any ICEmarket contract.

If you don't want to be a part of this service, you can request deletion of your account anytime by submitting 'DELETE' request from your registered email account to info@icemarket.info. ICEmarket obliges to confirm deletion of your account within 30 days of the received request.

Who has access to supplier-related information

Only the CEO of ICEmarket / Jadranski skiperi d.o.o. and a designated project manager can access full supplier information during communication with customers. Additionally, three executives from the software developer Calyx d.o.o. can also access this information, all covered under the non-disclosure agreement.

This is not optional and all users of ICEmarket are submitted to these rules for the purpose of the Website development, maintenance and customer support.

Display of advertising

The Website may display advertising served by us or by our service providers. We also allow third parties to collect information about your online activities through cookies and other technologies. The information gathered by these third parties is used to analyze and make predictions about your characteristics, interests or preferences and to display advertisements on our sites and across the Internet tailored to your apparent interests. We do not permit these third parties to collect personal information about you (such as email address) on our site, nor do we share with them any personal information about you.

Please note that we do not have access to or control over cookies or other technologies these third parties may use to collect information about your interests, and the information practices of these third parties are not covered by this Privacy Policy.
